OBJECTIVES

The objective of the program is to augment the delivery of agricultural and biosystems engineering services in support to the implementation of agri-fisheries mechanization, small scale irrigation and farm-to-market roads, post-harvest facilities and other agri-fisheries infrastructure projects of DA.

FUNDING

DOLE is responsible for providing the stipend of the interns which is equivalent to the highest prevailing minimum wage in the region. DA and its implementing units will provide orientation/training prior to the deployment and will provide travelling expenses and other necessary logistical requirements of the GIP for ABE Youth interns.

BACKGROUND

The Government Internship Program of Agricultural and Biosystems Engineering Youth (GIP for ABE Youth) is a collaborative program between the Department of Agriculture - Bureau of Agricultural and Fisheries Engineering (DA-BAFE) and the Department of Labor and Employment – Bureau of Local Employment (DOLE-BLE).

This program is in support of Section 24 of the Republic Act (R.A.) No. 10601 or the Agricultural and Fisheries Mechanization (AFMech) Law which mandates all Department of Agriculture (DA) Regional Field Offices (DA RFOs), bureaus, attached agencies and corporations to strengthen the provision of agricultural and biosystems engineering services on the implementation of agri-fishery mechanization, infrastructures and engineering programs and projects.

DURATION OF INTERNSHIP

The interns will assist the DA-RFOs, attached agencies, attached corporations and bureaus on their implementation of the agricultural and fisheries mechanization and infrastructure projects for a minimum of three (3) months to a maximum of six (6) months.

MINIMUM REQUIREMENTS OF GIP FOR ABE YOUTH INTERNS



Must be a licensed Agricultural and Biosystems Engineer (ABE) or BS Agricultural and Biosystems Engineering (BSABE) graduate.



No work experience; and



Must be 21-30 years old.
